New York City schools are filled with students who have potential and ambition to go far and we envision a city filled with students whose opportunities match their ambitions. Since 1995, we've played a critical role in bringing together business professionals, educators, and students to open eyes, open minds, and open doors. By doing so, we connect students to success.

Form 990, Part III, Line 4a - Program Service Accomplishments

In 2018, PENCIL connected approximately 2,000 NYC students to over 1,200 volunteers through its Partnership and Internship programs.

PENCIL's Partnership Program served 1,194 students across 49 New York City public schools by leveraging the talents and resources of NYC's business community to improve students' college and career readiness. These partnerships were supported by 33 companies. In a year end survey, Principals and key school staff reported the following feedback on the impact of PENCIL Partnership activities:

- 100% reported partnerships had an impact on their school - 70% reported a significant impact.
- 100% reported partnerships exposed students to experiences they would not have otherwise.
- 100% reported partnerships improved students' awareness of college and career options.
- 85% reported partnerships helped students develop positive relationships with volunteers.

The entry point to engage corporate partners is PENCIL's annual Principal For A Day® event. On May 8th, PENCIL facilitated meet-ups between 95 schools and 108 participants. Business executives participated by shadowing school principals throughout the day to learn firsthand the issues facing public schools, and to host

panels and career workshops for students.

PENCIL trained 728 students through its Internship Program. PENCIL placed 463 in six-week internships at 228 businesses across New York City. Of the 2018 internship cohort, 76% reported receiving public assistance and/or an income below the area median income. In total, these interns received over \$\$1.3 million in wages.

Business mentors and student interns also report that the Internship program had a positive impact on participants' communication skills, networking skills, professional skills, and their career awareness and planning.
