PENCIL is the leader in creating innovative and impactful models of collaboration between the business and education communities. PENCIL works at the intersection of school needs and business expertise to bring together the best ideas, talent, and resources across sectors to improve public student and school performance and enhance workforce pathways.

Form 990, Part III, Line 4a - Program Service Accomplishments

In FY16, PENCIL's School Partnership Program served over 80 New York City public schools by leveraging the talents and resources of the City's business community to improve students' college and career readiness and strengthen school leadership. These partnerships were supported by approximately 75 companies.

- 92% of Principals reported students have a better understanding of what to expect in college or the workplace
- 91% of Principals reported the Partnership helped improve students' awareness of their college and career options
- 84% of Principals reported the Partnership provided the school with access to knowledge, skills or resources that addressed school needs
